

The sadness of invention

I invented the "AC speed control motor", and its first part 1986 obtained invention patents from 13 countries, including China, the United States, Britain, Germany, and France.

The "starting current and speed control" of AC motors is a major problem that the world has been committed to for hundreds years since the advent of AC motors, and my invention solves this problem from a new perspective.

The motor is the basic product of the industry, with a wide range of applications and a large number; The motor is the heart of the supporting machine, the improvement of the motor performance, often can produce the effect of replacing the whole machine, therefore, the present invention has a huge market potential, a high economic value.

The power system of China's electric locomotives, including high-speed rail, uses this technology that I invented.

This invention of mine made China the most advanced country in the world in electric drive technology.

I'm 76 years old, but I don't have a pension and retirement health insurance.

I've been running around for 16 years. Complaint to the National Public Complaints and Proposals Administration 6 times since October 16, 2014, and the State Bureau of Letters and Visits has not handled them in accordance with the prescribed regulations and time limits, which ended in "archiving for future reference".

I filed a complaint with the Supervision Commission of the Central Commission for Discipline Inspection on November 1, 2017; I filed a complaint with the State Council Supervision Group on July 15, 2018, none of them responded.

After I graduated from the Department of Radio Electronics of Peking University in 1969, I obeyed the national unified assignment to work.

Follow the national advocacy and encouragement, in accordance with the national policy of the time and the Beijing Municipality", retain the status of the archivist as a state cadre for the departing archivists; The provision that the salary of archives will increase accordingly with the general increase of social wages" was separated from the "Beijing Municipal Environmental Protection Bureau" on September 17, 1992, and the personal files were kept in the Beijing Talent Exchange Center. File number 921085, became the legal representative of the "Yongning Mechanical and Electrical Technology Development Research Institute" of the Zhongguancun villagers' new technology enterprise that I founded, and I have been serving as a state cadre for 23 years.

At the retirement age of 60 in 2005, in order to handle retirement, I went to the Beijing Talent Exchange Center for the first time to go through retirement procedures, but I was told that I had to pay more than 100,000 yuan of social security funds during my resignation, then I could go through retirement procedures.

The enterprise I founded was originally vigorous, developed smoothly, and had good prospects, but due to the triangular debt of the whole society, the sales price of the enterprise could not be recovered, the enterprise could not operate, and it has been facing bankruptcy. After the state began to levy the social security fund, because the enterprise had no income, it did not pay the social security fund, which was agreed by the management committee of the development zone. At the same time, I don't actually have any income, and the business and I have been supported by my previous patent income. After the bankruptcy of the enterprise, I had no job due to illness, no income, and my social security fund contribution base was always 0. In addition, at that time, the state only stipulated that enterprises should pay the social security fund, and no one ever told me that I personally had to pay the social security fund, and I never had the concept of an individual paying the social security fund.

During my tenure, the total salary of 23 years added up to only more than 10,000 yuan. I am old and retired, but I have to pay more than 100,000 yuan before I can retire.

Is this society still reasonable.

The second time I went to the Talent Exchange Center to go through the retirement procedures, I learned on television that the State Council has new regulations on the retirement of employees. The reply I got was that they had heard about it too, but Beijing's rules on retirement had not changed. A staff member also said: Go to the sea to make a lot of money, do not pay the social security fund when working, retire and want social security, and the cheap are all accounted for.

The third time, I saw a notice posted by the neighborhood committee on the community bulletin board, which said that according to the spirit of the State Council, the application condition for social security in Beijing from January 1, 2015 was "to pay the social security fund for 15 years, at 60 years old". According to the state council's "state cadres' length of service is regarded as having paid the personal social security fund", my effective working experience of state cadres is 23 years, and my age has exceeded 60 years. I think I am fully eligible for this application for Social Security. On October 14, I went to the Talent Exchange Center for retirement for the third time, and the answer was that I must have paid the social security fund personally, even if it has only been paid for one month, so that the previous length of service can be recognized. Since I have never paid to the Social Security Fund, my previous years of service are not recognized. When I asked about the basis of this provision, replied: This is based on Beijing Municipal Order No. 183, which can be found on the website of the Beijing Human Resources and Social Security Bureau. When I questioned the reasonable legality of the provision, she replied: We only enforce the provisions, not interpret them.

I did not find the Order No. 183 on the website of the Beijing Human Resources and Social Security Bureau.

The working age of state cadres is legal and objective, how can it become a prerequisite for confirming the length of service in Beijing to pay a month's social security fund as a prerequisite, just by virtue of not paying a month of personal social security fund, can write off my 23 years of work as a state cadre?

Such a simple and clear matter, for such a long time, so many authoritative institutions just dare not ask questions, can not solve, in the end who gave them such abuse of power, who is this kind of grandeur, fearless power to govern behind the driving force and strong support?

Contempt for the central government, contempt for national laws and regulations, and wanton trampling on the legitimate rights and interests of citizens; Yang and yin violate, cover the sky with one hand, do whatever they want, dominate one side, and the secretary of the municipal party committee is the first responsible person.

Cai Qi, a rare upstart in the officialdom.

People use "triple jump" to describe a person's rapid promotion in the career, then the only thing used to describe Cai Qi is "pole vault". Cai Qi's jump not only skipped the "alternate members of the Central Committee" and "members of the Central Committee", but also this jump is still taking off, and the next leap point is the "Standing Committee of the Political Bureau of the Central Committee".

What is surprising is not only "flying", but also that in his career, there is no political achievement that can be brought to the table. Then, people can't help but wonder where the support point of Cai Qi's "pole" is.

Where there are strange things, there must be reasons for producing strange things.

The central authorities dismissed Guo Jinlong from his post as secretary of the Beijing Municipal CPC Committee, but Cai Qi spent a large amount of space at the new Beijing Congress of the Communist Party of China, making extremely praiseworthy remarks to highlight and praise Guo Jinlong.

Going against the trend is incompatible with his consistent statement that he must say that he is "highly consistent with the central authorities." Say a set, do a set, make such a big bet, who is he trying to please?! or so at the key point of his career, who guaranteed and recommended him, I think you can find the answer.

Without virtue, talent, but by connections, this is the root cause of the officialdom's gangs and factions, and the party's private interests, and Cai Qi's take-off highlights the deformed ecology of China's officialdom.

Who is qualified to recommend, on what grounds, what kind of responsibilities the recommender should bear, how to investigate, review, supervise, how to solicit opinions widely,

etc. If these official ecology is not effectively governed, then other reforms are water without a source and wood without a root. With the changes in the official arena, China's present day may not be the beginning of a "new era", but only a short-lived reproduction of history.

Liu Qi, Guo Jinlong, and Cai Qi are in the same vein.

Just such a sneaky horse, Cai Qi, who has formed gangs and factions, serves as the secretary of the municipal party committee, acts as a member of the Politburo, and the upper beam is not right and the lower beam is crooked; Things are clustered by categories, people are divided into groups, is the cadre team in Beijing getting better?

So why am I so unlucky, some people tell me, why is something so bad when it comes to me?

When I graduated from high school, because I had three consecutive years including all five points in all the main and deputy subjects, I had excellent character, and I was a good student in Beijing and a member of the Communist Youth League. My study has always been like this, I can complete my homework quickly, the school bag is in the desk, do not bring home, the rest of the time to play table tennis, I am a member of the school team, the youth amateur sports school table tennis team, but I did not enter the sports school for a long time, the sports school was stopped due to famine. In my memory, I went to bed at 8:30 every night, and then I was sleepy, I got up at 6:30 in the morning, and woke up when the time came, very punctual, all year round, every day, completely naturally formed, and this was also the case during the college entrance examination, until I went to college to adapt to the new schedule.

I studied easily, my grades were stable, I was the commissary in charge of study in primary and secondary schools, junior high school and high school were guaranteed to go to school, I ranked first in the National College Entrance examination in 1963, I was admitted to the Department of Radio and Electronics of Peking University, and was the cultural and sports commissary in charge of the class.

During the Cultural Revolution, I did not participate in any mass organizations, including the Red Guards and combat teams, nor did I post a large poster to anyone.

In 1976, due to science and technology, the Zhangjiakou Regional Military Sub-district gave me a third-class merit.

In my impression, parents never ask about their children's studies, but we study well in Tsinghua, Peking University, Renmin University, Beijing Medical University, Tianda and other universities; One of my uncles was a member of the American Academy of Sciences and the Academy of Engineering, a pioneer

in the world's optoelectronic communications, who led a US science and technology delegation to Visit China and was received by Deng Xiaoping.

All members of my family and social relations have no historical problems, are far from politics, and have been safe in all political movements.

Here, I just want to show that I have never been a "bad person", there is no "enemy" in society, and I have never wanted to be involved in politics, but just an engineer who is bent on scientific and technological development.

So why am I so unhappy, full of bad luck, like a shadow.

This is related to Shen Taifu and his Great Wall company.

Shen Taifu, former president of Beijing Great Wall Mechanical and Electrical Company, was sentenced to death for illegally raising funds and for "privately depositing 1 million yuan of public funds" and convicting him of embezzlement.

At the time of the crime, he had money in his hands. As we all know, the Great Wall Company is essentially a private individual enterprise, no matter what happens in the company, Shen Taifu alone said, that is absolutely calculated, he has to spend money, such as taking things from the bag, that is to say, the money in the company, he spends it casually, he does not need "corruption" at all.

For the sake of his career, Shen Taifu can "punch his swollen face and become fat", and he dares to take any risk, and even do everything he thinks needs to do, but there is only one thing that cannot be done, that is, "corruption", because "corruption" has no meaning to Shen Taifu, and he does not need to "embezzle" at all.

As the prosecution complained, Shen Taifu used the "privately deposited" public funds for bribery.

Then if it is said that this 1 million is the unit public funds, and he uses this 1 million for the company to pay bribes, it is a company act, Shen Taifu, as the legal representative, should bear the responsibility of the legal person to pay bribes, and its "private deposit" is just its specific bribery method, and the nature of personal "corruption" is completely different, there is an essential difference.

In that era when everything had to be studied "tobacco and alcohol", no bribery, no back door can't to do any thing, bribery was already a very common helpless move. Good in bribery can go through the back door, that is called ability, that is enviable, admirable skill, this is the whole society at that time known and recognized common sense.

Shen Taifu's illegal fund-raising was completely public from the very beginning, and was carried out with great fanfare under the official advocacy, connivance and support, and many units and individuals enthusiastically raised funds based on the "official attitude."

Shen Taifu's large-scale illegal fund-raising, who is at fault, who is guilty.

Whether it is subjective motives or objective reality, Shen Taifu cannot constitute "embezzlement" at all, but the reality is that the Beijing First Intermediate People's Court tried the first instance, and the Beijing Higher People's Court finally tried and approved the death penalty, which privately deposited one million public funds in this case and characterized it as embezzlement of one million. Shen Taifu was sentenced to death for this crime.

Obviously, Shen Taifu's crime of "embezzlement" was "referring to deer as horses, which was hard to buckle. In fact, as far as some people are concerned, it is not important to condemn Shen Taifu, what is important is to let him shut up forever, and not to involve others, let alone involve himself, these have become the only criteria for convicting Shen Taifu. However, whether it is illegal fund-raising or bribery, the heavier the crime, the higher the level involved, and obviously, this is precisely what these people are most taboo and most afraid to avoid. Try to measure, only the hat of "greed" is the most suitable for Shen Taifu, which can not only "do things by one person", but also make him shut up forever, One finished, all is finished.

These people succeeded.

For this case, the people were in an uproar and there was a voice of doubt.

After the final trial, television stations and many other media reported on the high profile, and a grand commendation meeting on the Shen Taifu case was held in the Great Hall of the People, and commendations and commendations were given to various judicial units involved in the case and many "meritorious personnel" who were involved in the case. Such a solemn commendation meeting for a single case is extremely rare, which demonstrates the control and recognition of the case by the top level of the state, and has also become a warning that no one is allowed to be involved in this case again.

The voices of the crowd have since disappeared.

Senior leaders of the State Science and Technology Commission, the Ministry of Mechanical and Electrical Engineering, and the Zhongguancun New Technology Development Zone knew exactly as early as 1990 that Shen Taifu was a debt-laden empty shell, but they continued to hoodwink the public in various ways, and the tone became higher and higher, so that in China's most authoritative "People's Daily", Shen Taifu was compared to the dragon symbolizing the Chinese nation.

With the mainland's official control over the news media, the people who can make the "People's Daily" publish this article are by no means ordinary people, ordinary officials, and by no means ordinary officials, even if the politburo members do not have this right, they do not have such courage.

Similar, a large number of propaganda, including the central radio station and other central and national media; Including the State Science and Technology Commission, the Ministry of Mechanical and Electrical Machinery and Other Central Ministries and Commissions, as well as various official

red-headed documents of governments at all levels nationwide, it is the basis for Shen Taifu's large-scale and large-scale illegal fund-raising.

In fact, Shen Taifu's illegal fundraising was only the first step, and its ultimate purpose was to get his Great Wall company listed, which was only one step away from the social background at that time. Once the Great Wall Company is listed, all the deficits of the Great Wall Company, all the huge debts owed to the bank and the corruption behind them will be covered up and smoothed out by the listed companies, everything will become legal, and the Great Wall Company will become an inexhaustible cash machine for some people.

Ordinary people are asking, such a large-scale stroke, Shen Taifu is simply unimaginable, then who is Shen Taifu's real backstage pillar, who is blinding the public, why should he do this recklessly.

The common people also asked who had such great power and influence at that time and could illegally manipulate the state judicial organs to kill people and kill people. Obviously, there is no one person who can do all this, this is an interest group with a deep background.

At that time, it was Zhu Rongji, then vice premier, who broke this shady scene, and what kind of courage and wisdom was needed to face such an interest group with a profound background.

The people are also asking whether the NPC Standing Committee supervises one government and two procuratorates, but if someone at the highest level of the state is suspected of violating the law, who will supervise it, and how will it supervise it?

The common people say: A great official who kills a person is like twisting an ant to death.

Ordinary people say: Shen Taifu is a freak born of distorted society.

Shen Taifu and his Great Wall Company are well-known at home and abroad, and they are also famous for the great impact of their illegal fund-raising. Only from the "Mercedes-Benz" convoy when he traveled, there were police cars to open the way for him, there were police officers on duty to salute his motorcade, and often held his company activities at the Diaoyutai State Guesthouse, which shows the size of its office and the high specifications.

At that time, when the car symbolized the identity and the private enterprise had no social status, it was such a courtesy to such a private enterprise boss; In the absence of asset collateral, a private enterprise can borrow a large amount of money from state-owned banks, and the breadth of its social network and the depth of its social network can also be seen.

In addition to Shen Taifu's extraordinary social skills, he is willing to spend money and dares to spend money. Take money to make the road, use money to create momentum, and use momentum to collect money.

Shen Taifu is a person who spends money with all his heart and can make ghosts large and small push and grind for him. Can someone who hangs out with ghosts all day have good results?

There are some people who can easily lift you up to heaven, or they can kick you down to hell with the same ease.

Confession from the wide, prison bottom sitting wear;

Resist strictness, promote officials and get rich;

The main culprit behind the scenes, with impunity;

It is commonplace.

The person who put Shen Taifu to death was a person with both yin and yang, on the one hand, the sun was shining and the smile was lovely; On one side are green-faced fangs and fierce. They are two-faced, sinister and vicious, and they can do anything. These people have a high social status and great power, and their power colludes with the judiciary, abuses their power, and manipulates the judiciary.

Framing and slandering and accusing deer of being horses is a set of habitual tricks that these people are handy, and with the judiciary escorting them, they can succeed again and again.

I was the vice president and chief engineer of the Great Wall Company, and one of the main founders of The Great Wall Company, Beijing Great Wall Machinery and Electricity Company is famous for the new technology enterprise registered with the patent of the former motor I invented.

It is in cooperation with Shen Taifu that the motor I invented began to really start, quickly turning from an idea into a real product, and verifying the performance of the product; It was also the cooperation with Shen Taifu that I got rid of the situation that was very difficult in all aspects at that time.

Our agreement clearly stipulates that we are only the cooperation of economic interests, he invests in me, I give him a commission of interests, I am a completely independent administrative body, and I am in charge of matters related to the motor. Only at the request of Shen Taifu, the motor department I am in charge of is temporarily located under the name of the Great Wall Company, and I can be separated and independent at any time.

I repeatedly gave in to change the agreement, and he repented when he raised his hand and did not take the agreement seriously. He asked many professors of the Department of Electrical Engineering of Tsinghua University to be his technical advisers, he had the development zone, the Ministry of Mechanical and Electrical Engineering, the State Science and Technology Commission as the backing, he thought he could get rid of me, he recruited dozens of people at 50 yuan per person in the Four Seasons Green Commune, took a truck to my office to fight, grab, That was the direct cause of my complete separation from him.

Shen Taifu's first bank unsecured loan was 300,000 yuan, and when I left the Great Wall Company in 1989, I heard that he had borrowed tens of millions yuan, and then it was even more viciously inflated, since then. After that he had the development zone, the Ministry of Mechanical and Electrical Engineering, the State Science and Technology Commission of the full support, he had no scruples, violated the agreement and the patent law, I complained to the development zone, the Ministry of Mechanical and Electrical Engineering, the State Science and Technology Commission to stop him, no one paid attention to me, but he did not know that the technology at that time was only to verify the technical performance of the motor, not complete, he encountered a bottleneck that he could not solve when this technology was expanded and implemented, making him in a desperate situation.

If we can learn from each other's strong points and cooperate tacitly in a good social environment, we can really achieve a big cause. Such a good invention, our cooperation did not bring wealth and joy to Shen Taifu, but caused him to die, every time I reflected, his death is always related to me, I feel very sad and deeply guilty. he has been playing my signboard, let me sign the motor cooperation agreement with other units that I have not participated in at all, and the ghost of the dead is probably not Shen Taifu, but me; Perhaps, I became Shen Taifu's martyrdom.

Although I still still don't understand what I should have done to make it better, it always has to do with the fact that I was never sociable, that I didn't handle things properly, and that I was sad and deeply guilty about his death.

Shen Taifu's death was an indelible heart disease of those who had put him to death, and they were worried all day long, but after all, this was a murder case that took advantage of the deliberate murder of the state judicial organs and the crime behind the murder that made their hearts jump. And the invention of the motor has become a sharp blade to pick up this abscess tumor, they like to treat Shen Taifu by any means sinister to treat their adverse things and people, the invention of the motor has become their target of crazy murder for cover up their own history of evil.

Mayor of Beijing; Liu Qi, secretary of the Beijing Municipal Party Committee and member of the Politburo, was involved in the case, and of course, he was only a pawn.

I have never known those who have put Shen Taifu to death in front of and behind the stage, and I have never had any contact, I just want to avoid those high-ranking officials from a distance, but as the inventor of the motor, I have still become a target for corrupt high-ranking officials and an innocent victim.

The invention patent application for the second part of the key part of the motor technology I invented was refuted by the Intellectual Property Office as "insufficient disclosure".

The invention patent application specification is only one page, such a simple invention patent application, the State Intellectual Property Office has examined for nearly 8 years, and the invention patent validity period is 20 years.

During the trial, the examiner in this case violated the review rules; Many of the examination opinions themselves are clearly contrary to patent law.

In the reexamination opinion of the Patent Office, completely disregarding the facts and without putting forward any reason, it was just arbitrarily asserted that I had used a special variable speed transmission mechanism in the invention, and on the premise of this, I did not explain this "special transmission mechanism" that did not exist in the invention, thus determining that I was "insufficiently disclosed" and rejecting my patent application.

The modern version of the true "point to a deer, call it a horse".

I filed a lawsuit with the court under the Patent Act. At the trials of the Beijing First Intermediate Court and the Beijing High Court, the defendant remained silent in the face of all cross-examination of the evidence by the judges of the two levels of courts, and did not express any objection to all the statements that I deserved to obtain the patent right.

The judges of the two courts were impartial in the trial, but the judgments of the two courts completely ignored my defense opinion and the actual situation of the trial, and only copied the conclusion of the examination of the State Intellectual Property Office, rejecting my claim as "insufficient disclosure".

In the course of the trial of the case, there were many problems in many aspects:

Patent examiners face the content of the application is all-encompassing, but also the world's latest technology, many are the world's top scientists and their teams for many years of research results, its examination content beyond the scope of the examiner's professional and knowledge, even from the unheard of is inevitable, the examiner can not understand, it is impossible to understand the specific technical content of these applications in a short period of time, so the review can not go deep into the specific technical content, The problem could only be addressed from the common level of patent protection. However, the treatment of my patent application violates the practice and principle of patent examination, and the examiner not only goes deep into the specific technical details, but even requires me to pass only one patent application specification, so that a completely lay examiner can "understand" the content of the invention, otherwise it is "publicly insufficient", which is simply impossible for any specification. The reason why the examiner resolutely does this can only be that the conclusion of "dismissal" has been determined before the trial, and the examination has become a search for the basis for the existing conclusions, but he does not understand the motor and machinery, and he is pulling hard, and only by relying on his own imagination and understanding, there are many layman's problems and various illegal acts in the review opinions.

The period between my application for review and the issuance of the notice of review lasted up to one and a half years. Before issuing the notice, I had asked the Review Committee of the Property Office once, and the front desk staff was very familiar with this application, and as soon as they mentioned it, they immediately knew that the review team had just been established recently, and had not been established before.

As a normal procedure for patent examination, the "Reexamination Board", as a specialized body for patent reexamination, was unable to form a reexamination team for up to one and a half years to request reexamination of this case, which also shows that the examination of this case is extremely abnormal.

The notice of review said that "the original review department insisted on the opinions in the decision to reject", indicating that there were differences between the review team and the original review department's opinions, and that they had repeatedly done persuasion work, so that there would be "persistence". So, which of the opinions of the review team or the review department is more authoritative; Where does the review department come from, and who should listen to whom; If the review team's opinion must be agreed to by the review department, is the review procedure still useful, and why is such an anomaly occurring?

Furthermore:

1. The second instance examination of a patent should be an examination of the applicant's opinion of the first instance, but the intellectual property office's examination opinion on the second instance of the case has gone beyond the scope of the first instance's opinion, saying that it is a "continued examination" of the patent application, and a new reason is put forward that is completely beyond the scope of the first instance, and the examination opinion in the second instance that exceeds the scope of the first instance objectively becomes the first instance, which has violated the essential meaning of the "second instance", and the second instance is illegal.

2. After the second instance, I communicated with the examiner in the patent examination room of the patent office and explained in person that she had raised the problems, and our communication was still very harmonious. She said that the examiners of the first instance were no longer hearing the case, that she had taken over and that she would take my opinion into account.

The examiner of the first instance was a student of electricity, she was also a student of electricity, and they did not understand the motor and machinery.

It is rare for examiners to be replaced, and the same people who do not understand motors and machinery are replaced. Changing examiners in the course of the trial of this case is not a simple matter.

After reading my reply, the examiner of the first instance was inclined to approve the patent application, but it was strongly rejected, and the examiner either took the initiative to

request to be transferred from the case in order to adhere to his own opinion, or was forcibly transferred from the case by the leadership.

3. After the first instance trial of the First Intermediate People's Court, the defendant told me that there were some technical questions to ask me, and I answered all the questions to him, and she did not express any opinion on the technical issues. Before leaving, she said, if you lose this case, you should not insist on it anymore, and if there is an application in the future, it will provide you with convenience.

The defendant was confident at the very beginning of the judicial proceedings in this case and already knew the final outcome of the trial.

Now that she know that I am bound to lose this case, why should I be asked about the technical problems of this case? Obviously, this is just an excuse to convey me the message.

Later, while I was sorting through my stuff, I found out that all my documents had been taken by her. When I got home, I wrote a letter to the judge of first instance explaining the above and saying that the surveillance video in the courtroom should be available. Since I don't have any information at hand, I hope the judge will send me a set. A few days later, I received the information sent to me by the First Intermediate Court through the express mail, and the information I am submitting now is not a copy of the original document, but a copy of the information given to me by the First Intermediate Court. In the information sent to me, there was a missing copy of the "review decision", and I did not bother to ask the judge for it again, so this one was missing in the information I submitted. In addition, the annotations and marks on the copies I submitted were not written or crossed by me, but should be the handwriting of the judge.

4. Before the second instance trial of the Beijing Higher People's Court, the defendant said loudly in front of me that he wanted to find a vice president of the high court and submit a letter to the vice president, and the clerk said that the vice president had been transferred, and the defendant said, then look for your president.

Obviously, this letter is not small, and this letter is related to this case.

The SIPO not only made fundamental errors in its conclusions, but also suspected of dereliction of duty and abuse of power.

The court's decision was improper, and fairness and justice were lacking.

Being able to use the highest competent administrative organs of the state, the use of the national judicial system, the ability to mobilize such a high level and wide range of state resources at will, and the courage to act recklessly and without scruples shows the high level and number of corrupt officials whose interests are located.

According to Article 91 of the current Administrative Procedure Law, it is clearly stipulated that:

- (1) There is truly an error in not filing a case or rejecting the prosecution;
- (3) The main evidence for the facts ascertained in the original judgment or ruling is insufficient, has not been cross-examined, or is fabricated;
- (4) The original judgment or ruling applied the law or regulations in error;
- (6) Where the original judgment or ruling omitted a litigation claim; It is possible to request a retrial by the court or the procuratorate to protest.

In the new era, I think that China's rule of law environment will be better, "so that every citizen can feel the fairness and justice of the judiciary", such an obvious wrong case, in January 2018, I successively asked the Supreme Court and the Supreme People's Procuratorate to review the telegram The patent application for the machine, however, was categorically rejected for various reasons and for various imprecise and unreasonable reasons, and the request for retrial of the case was not accepted.

Is there still a place for reasoning in China?

My doom followed, some of which were clear and well documented; further are unclear, difficult to verify, and even vicious events.

What is said here is only clear and well documented.

Since 1993, enterprises have become more and more difficult because of triangular bonds, and have been struggling on the line of life and death, until 1999, the Beijing Municipal State Taxation Bureau issued a notice of new registration of enterprises from the national tax, requiring enterprises to register their domicile must have a real estate certificate. According to the relevant provisions of the enterprise registration of the new technology development zone, the family residence in the development zone can be used as the registered residence of the enterprise, at that time my family was in the development zone designated by Beijing, and the property rights of the house had already been purchased, but the real estate certificate had not been issued for several years, I reflected this problem to the national tax office of the development zone, and said whether it was possible to replace the real estate certificate with the purchase invoice, and the answer was that there must be a real estate certificate. In the case that the enterprise has no income and business activities at all, and can not see the day of the beginning, and then rent a house with a real estate certificate at a high price, it is too risky for the enterprise, so in September 1999, I could only decide to cancel the enterprise, enter the procedures for deregistration of my enterprise, and complete the cancellation of the national tax registration and local tax registration of my enterprise.

The real estate certificate became the last straw that crushed my business.

This provision is like tailor-made for me, after the cancellation of the enterprise, not only the 100,000 yuan spent on applying for an international patent sink into the sea; The hundreds

of thousands of goods owed to me by the state's military enterprises were written off; There is also no way to talk about the royalties payable to me by the contract cooperative; One of my products weighs a ton, and people can't move it; Storage, no place to put, existing finished products, a large number of semi-finished products, parts, supporting control devices can only be treated as scrap copper rotten iron.

The losses were heavy.

What's more, it was obviously a legally deregistered enterprise, and two years later I accidentally learned that, without my complete knowledge, it had impersonated my signature, and for no reason, my business was revoked by the Haidian Industrial and Commercial Bureau in August 2000.

In May 2000, I received a call from the Industrial and Commercial Office of the Development Zone asking me why I did not participate in the annual inspection of the enterprise, and I said that I was sick and almost died. I have completed the cancellation procedures for national and local taxes, but I am only close to canceling the industrial and commercial registration, because I can't walk on the ground, can I do it again later? After a while, the staff member called me again and said that the Haidian Industrial and Commercial Bureau wanted to transfer my company files and told me to find a way to handle it as soon as possible no matter what. The next day, I entrusted someone to go through the formalities for industrial and commercial cancellation.

On October 2, 1999, my left leg suddenly swelled and ached, and I went to the People's Hospital for treatment, and the first time I saw a doctor, I was diagnosed "Deep vein thrombosis", but several times did not do effective treatment, at this time my illness is already very serious, the left leg is twice as thick as the right leg, the color is purple, very painful. A nurse I didn't know took the initiative to tell me, you don't be treated here, go to Anzhen Hospital. When I arrived at Anzhen Hospital, I was hospitalized as a critically ill patient in an extra bed, and then I learned that "deep vein thrombosis" is a serious disease that can cause death.

The nurse saved my life.

During my hospitalization in Anzhen Hospital, one night, in the case that my body did not have any abnormalities with the usual, nor did any doctors inform me in advance, suddenly a middle-aged nurse gave me a hanging needle, and after a while, I felt panic, my heartbeat intensified, and then my heart ached, more and more painful, I shouted to the doctor, but no one paid attention to me, I pulled out the needle myself, after a long time, The nurse came again, said nothing, and took the hanging bottle.

The next day, when the doctor was on a round, multiple doctors were present, and I told the attending doctor about the previous night.

He didn't prescribe the medicine, but he didn't say anything.

A few days later, also at night, two young nurses came and said to test my blood and draw blood from the vein at the base of my right thigh, and then my thigh hurt for a long time, about a month, and now I can still clearly touch many large and small lumps under the skin of my right leg.

I wondered how the blood test was drawn at night, and the doctor did not mention it to me before and after the incident. Due to the prolonged leg pain, I talked to the attending doctor, who looked at it and didn't say anything.

Later, I went to Anzhen Hospital, waited for a long time, and told me at the registration desk that my major medical records could not be found.

"Yongning Mechanical and Electrical Technology Development Institute" was founded and operated entirely with my own funds, in order to preserve the value of the funds, I continued to purchase regular treasury bills under the name of the unit from beginning to end, April 1 2002 On the day, I went to the Bank of China Zhichun Road Savings So a full set of legal procedures to redeem the due Treasury Bills, because the unit had been revoked at this time, I asked to deposit them into my personal account. The Bank of China suddenly and loudly announced in public in the business hall for no reason that I had "deposited public funds privately" and would not be redeemed.

I complained to the head office of the Bank of China, and soon I received a call from a person claiming to be the Bank of China, in which the other party had a brutal and vicious attitude, and again fraudulently refused to pay.

The Bank of China seized 150,000 yuan of principal and interest on my five-year fixed-term maturity deposit, which has not yet been redeemed.

Killing Shen Taifu for the crime of "private deposit of public funds", this time he wanted to impose this crime on my head, and convicting people can also be addicted.

As an enterprise, does the Bank of China have the right to convict citizens, and why not hand them over to the judicial organs and privately withhold depositors' deposits on trumped-up charges is not a "private public court"?

I accused the defendant of slandering the plaintiff for privately depositing 150,000 yuan of public funds, infringing on the personal rights of citizens; The defendant forcibly seized 150,000 yuan from the plaintiff, infringing on the property of citizens" as the ground, and filed a criminal and incidental civil lawsuit against the Bank of China.

According to the standard at the time of the case, 150,000 yuan was already a particularly large amount of money involved, but neither court held a trial.

The Haidian District Court dismissed the private complaint on the grounds that "there is no evidence in this case".

I appealed to the First Intermediate Court. The First Intermediate People's Court stated: "The crimes of defamation and misappropriation stipulated in China's criminal law can only be constituted by natural persons, and there is no legal provision that can also be constituted by legal persons, and there is a lack of evidence of guilt", "the appeal is rejected, and the original ruling is upheld".

In the Criminal Law and the Criminal Procedure Law, there is no exclusive "natural person" or "legal person" for any crime, and according to the court, in China, a legal person can frame and slander others, and can embezzle a huge amount of property of others without bearing criminal responsibility.

On November 29, 2017, I filed a complaint with the First Intermediate Court in accordance with the law, and the First Intermediate Court refused to accept my request for appeal on the same grounds.

It was also in order to sue the Bank of China that when I followed the court's request to the Haidian Industrial and Commercial Branch to issue a certificate of cancellation of my enterprise, I found that my enterprise had been revoked.

In my impression, it was this bank that first gave Shen Taifu a loan. Shen Taifu knew that everything was difficult at the beginning, as long as there was a first loan, it would be easy to handle later. Therefore, this first loan is not a large amount, but Shen Taifu spent a lot of energy and a lot of money. After that, the amount of loans rose sharply, and Shen Taifu was able to borrow a large amount of money from state-owned banks without any collateral, and bribed with bank money, and the amount of money sold was always amazing. In the face of huge debts, Shen Taifu's most common sentence in front of everyone is "I'm not going to collapse".

Shen Taifu only thought of the background behind those people, the great power, they could protect him; He only thought of "honor and disgrace together", I suffered, you can't run, but he never thought that the person who can easily lift him to heaven can easily kick him down to hell and kill people.

Bribery, loans, re-bribery, re-lending, forming a vicious circle, the bank's illegal loans eventually harmed Shen Taifu.

I heard that there is a kind of dog called pug. Folk rumors, "dog eyes look down on people", but it is not the case, pugs are particularly good at looking upwards.

I heard that there is a kind of dog called a wolf dog. Folk rumors, "dog fighting human power", this sentence is very appropriate, vividly portraying the temperament of this kind of dog.

I heard that there is also a kind of dog, called hybrid dog, folk commonly known as dog hybrid, also known as lackey, which concentrates the characteristics of pugs and wolf dogs, so it is the most pampered by the owner.

Dog bastard, abominable.

In fact, the owners of these dogs are more hateful than these dogs.

In China, as long as the officials are above the average enough, they can ignore the Constitution and laws, do whatever they want, act arbitrarily, and act arbitrarily, and no one dares to take care of it, and no one can control it.

In Beijing, under the influence of power, it is not uncommon to frame, slander, and accuse deer of being horses, and the people's personal and property have been wantonly infringed; How blatant and arrogant is the collusion between power and the judiciary; Unfair judicial decisions, complaints, complaints are ignored. Behind the harmonious smiling faces, these party sticks were a mob of superficial apparently benevolent and moral villains, and a mob of open robbers.

The Chinese idiom of "lawlessness" says that a society without the rule of law is a society without daylight, a dark society.

Only in a country of fairness and justice, democracy and the rule of law can the people take charge of their own destiny; In a society that ignores the rule of law, there is no legal reason, only hegemony, and the people can only be forced to accept the reality imposed by hegemony. In such a society, even good people are difficult to be, yesterday, today, innocent victims are others; Tomorrow, the day after tomorrow, the primitive power falls from the sky, and the unlucky one will be themselves.

In such a dark social environment, I can still be safe and sound, and I feel that someone has been protecting me, and if I am not mistaken, is a very prominent member of the Politburo Standing Committee, only he has such ability, such a heart.

Once, the neighborhood committee called a meeting of residents, and after the meeting, a staff member specifically said to me, I can't see them, they can see me, they are in the car.

I would walk along the road every day, and on a few occasions some people would intentionally or unintentionally assemble in front of me, dressed in civilian clothes, about 20 people.

A group of people in the community surrounded the building where I lived, shouting exercise slogans and running around in circles.

In the empty mall, seven or eight young people suddenly gathered around and talked to me.

I think they're warning to whom.

During a walk, a tall and burly man suddenly stepped out of the public toilet and deliberately clinked to me, walked side by side with me for more than 10 meters, and then hurried away.

During a walk, suddenly a young man riding a flat three-wheeler rushed towards me, and I pressed against the wall and the car brushed away.

Once, a plainclothes police officer of the Xicheng Public Security Bureau, accompanied by a police officer from our community, came to my house to talk to me because of an article published on my own legally registered "Democracy and The Law" website, and without saying a few words, there was a fierce knock on the door and the woman's shouts, and the film policeman said "It came really fast", went to open the door and said a few words, and immediately came back and hurried away with the police officer. I came across the officer when I was sent out the door, he was sweating profusely, and I asked, how did you sweat so much?

Heating companies because of the "coal to gas" greatly increased the heating fees of residents, I asked the heating companies to first hear and then raise the standard of charges in accordance with the law and disputes, the heating companies first threatened and intimidated me with foul language on the phone like the underworld in the movie, and then sued me in court, at the second court, the representative of the heating company brought a young man with a very flowing appearance, and pointed at me and said" to him, "It is him", At the same time I saw a middle-aged woman who neither of us knew was always following us. At first the young man sat down with the representative of the heating company, and under the reprimand of the judge, the young man sat in the auditorium.

There is a TV series called "Laughing and Living".

People should live with a smile, face everything calmly, do what they are determined to do with a normal mentality, and be mentally prepared enough to deal with everything that may happen in the future: these gangs of party sticks, a group of underworld leaders, and scoundrels can do anything.

某省：头6个月机电业近1/3企业处于停产半停产状态；

在著名的北京中关村“电子一条街”，长城机电集团公司可以说是后起之秀。两年多以前，它还只是外地来的几个年轻人组成的小公司，两年以后，这个专门从事新技术、新产品开发、研制、生产、经营的企业，以机电行业为发展重点，开发了交流调速电机系列等高新技术新产品，目前已扩展到化工、冶金、医疗器械、轻工等行业，拥有中外专利技术40多项。公司成员已扩展到600多人。

公司总裁沈文福，毕业于清华大学，是位北京人。

自己的一条龙

机电集团公司怎样 机结合的道路上前进

我是个幸运儿。但命运好并不等于成功，干大事还要敢于冒险。”沈太福从不隐瞒自己的观点，怎么想，就怎么说。

1984年8月，太福辞去了长春市经委干部公职，自立门户办起了科技咨询服务公司。那时，长春恰逢“疯狂的君子兰”之时。沈太福的父亲又是一位商业科长。但，太福不想当“倒爷”，他想搞科技产业，因为中国技术太落后。

当时的长春市长陈振康很有眼力，指示原宽城区委书记于默帮他忙。然而，他却偏偏选中一个街道企业——长春锅炉厂。这个厂130名职工，有124个是妇女，已停产几个月。他去后，带领大家开发新产品，当年获利47万元。这年年底，他们同时又搞双色水位计。1986年产值2300多万元，产品销往全国，事业越来越大，他于是想进京干了。

1988年过了元旦，沈太福便带着几位助手，闯入京城，短短两个月，竟拉起一支180多人的队伍，大专以上学历的高达90%。他依然在京城站住了脚跟。1989年3月16日，试验区胡昭广、胡定两位主任特批他们在试验区安营扎寨成立公司。

沈太福与众不同的，是他始终坚持搞科技产业，而对那些专搞洋货发家的行当一点也不感兴趣。无级交流调速电机就是他创业以后，带领弟兄们克服种种困难，经过日日夜夜的苦心钻研和改制搞成的。如今，他已是中国专利项目最多的人。从1985年到现在，短短几年中，沈太福共获各类专利近300项(其中28项与他人合作)，仅今年9、10月份就申请了250多项，创下了中国之最。

刚接触沈太福时，你会觉得他不仅胆量大，而且是个爱说大话的人。矮个头儿，两鬓黑须，满口的东北腔，说起话来像是弹钢琴。反正他说的干的，都可归结为一个字：“大”。在长春时，他就提出“京有四通，我有长城”的富有挑战性的口号，到了北京以后，他又大胆地把口号改成：“美有通用，我有长城”。足见其“野心”之大矣。

宝刀在手，无畏无惧

常接触进口产品的人知道，某种产品我们刚刚进口两三年，国外就停止生产了。不断开发新产品是当代生产的重要特征。

电机的出现在世界上已有100多年的历史了。作为机械运转的心脏，电机必须有定子和转子，这似乎成了天经地义的常识。然而长城机电集团公司发明的无级调速交流电机却没有定子，只有两个转子，靠两个转子的相对运动，可以在零转和数千转

这种新型电机，在我国现有电机厂不需要更新设备就可以组织生产，不仅可以带动整个行业，而且对所有使用交流电动机的企业都有深远影响。它可广泛应用于机械加工、冶金、矿山、纺织、化工、交通乃至自动生产线、建筑(塔吊、电梯)、各类风机水泵等，使现有的许多机电设备有根本性的改进，并能在各行业开发出一系列新产品。假如全国所有风机、水泵全部换上调速电机，仅此一项全国一年就能节电400亿千瓦时。

发达国家调速电机和特种电机的用量，占其电机总千瓦数的80%，而我国只有20%，使大量电力浪费在无功损耗上。我国虽然耗资进口数千条变频装置生产线，由于主要元器件仍依赖进口，加上该装置成本比电机本身的价格要高出几倍甚至几十倍，以及维修技术上的问题，在全国范围内推广应用变频调速技术，企业有许多困难。

正因为如此，沈太福总裁当初才果断拍板，不惜血本，直接和间接投资300万元，用以试验、研制和生产无级交流调速电机。从长春转移到北京后，他携儿带妻，不顾及设置自己的“安乐窝”，就同伙伴们先租用中关村第三小学的几间房屋，挑灯昼夜苦干，后又搬迁数次，在四季青，他们吃住在机械厂车间，一连奋战了几个月。

正因为如此，国家计委、科委、机电部等中央政府部门以及北京市政府、试验区的领导同志，对长城机电集团公司的新技术产品开发和推广都极为重视。1989年10月，长城机电公司向国家计委呈送一份“关于成立交流调速技术经营发展中心的报告”，原国家计委常务副主任房维中同志于11月21日在批示中认为这是

“属节能的重要项目”，要求“尽可能给以指导和支持”。机电部第一装备司对长城机电公司在交流异步电机调速方面所取得的成果十分重视，并将长城公司系列调速电机纳入行业管理。1990年9月27日，第一装备司向全国电机厂发函，建议他们迅速积极配合。国家科委成果办最近决定于12月上旬主持召开全国无级调速电机推广大会。

在10月底至11月初举办的全国新技术产业开发试验区成果展览会上，宋平、宋健、邹家华等领导都分别仔细地观看了长城公司展示的无级调速电机，并对此给予充分肯定和鼓励。

发展高技术产品是历史赋予我们的重任。长城机电集团在调速技术方面领先了一步。宝刀在手，无畏无惧。他们瞄准机电行业之所急，紧紧抓住科技成果迅速向生产力转化的关键，果断决策，终于踏出了一条既符合国情又领先世界的民族机电工业发展新路。也许，这就是他们得以迅猛发展，并以巨大的能量向社会释放和辐射的奥秘所在。
