I invented the AC variable motor.

Before, the start and speed regulation of AC motor is using frequency conversion power supply, this technology is widely used, and is well known to the world, has become a common sense in popular science.

Local technology invented by the Chinese people, but the national government strongly denied it, so who abroad will say that it has adopted the technology that was invented by China.

The main key technology for high-speed rail is the powertrain, and Siemens offered \$1 billion in the negotiations to introduce the technology.

My technology completely subverts the original power system.

That's just my technology applied to high-speed rail.

Motor is a basic industrial product, wide application range, the number; motor is the heart of the whole machine, the improvement of motor performance can often produce the effect of making the whole machine replacement. Therefore, the invention has huge market potential, very high economic value, and will have a profound impact on the future.

Now, as the core technology of the mechanical heart, it has become a technology that anyone can use without an inventor.

I am the inventor of this technology, in the field of motor, the world is exclusive. However, this is just an inference, no legal basis, is not convincing, I will not only lose hundreds of millions of dollars of huge wealth, and also think that I am a criminal fraud, so my invention must be confirmed by the legal level, which is why I want to fight the lawsuit to the end with half my life.

In 20 years, I have called for fairness and justice in various ways. I have been writing a complaint letter to the Supreme Procuratorate for more than a year, not even answered.

All my indications are true, and the conclusions are simple and clear. Twenty years of real-name accusations, if I had a problem, would have caught me. I need to hire lawyers to deal with international litigation. With my financial strength, even if I am bankrupt, I cannot afford to hire lawyers, so I can only find partners in a community of interests. I will do my best to find partners with international influence.
